CIAC was established in the Year 2006 jointly by Construction Industry Development Council (CIDC) and Singapore International Arbitration Centre (SIAC). CIAC has been identified by Ministry of Law & Justice, Government of India, as one of the nodal organisation which can be approached for dispute resolution purpose. CIAC has observer status with UNCITRAL Working Groups and has been participating in their meetings.

CIDC was established in the Year 1996 by the Industry and Planning Commission of India (now Niti-Aayog). CIDC has taken several initiatives for the development of the industry such as Advice the Government on policy formulation related to construction industry, Standardization of construction contracts and procedures, Dispute Resolution in Construction Contracts, Interaction and networking with international organisations to promote emerging technologies and best practices, and publishing the Construction Cost Indices since 1998.
